### Registration:

- Select the "Account Services" link
- Complete the step-by-step registration process

Regardless of your situation, user-friendly screen prompts will guide you through the process.

### Enrollment:

- Enter the User ID and Password created during Registration

- Complete the step-by-step enrollment process, which includes:  
— Entering contribution information  
— Identifying beneficiary designations (if applicable)  
— Selecting investments  
— Providing information regarding account consolidation (if applicable)

### Consolidating retirement accounts
